### Project abstract:

The topic of this PhD proposal is the Music for saxophone in Italy between 1930 and 1960. It is a short period but is full of interesting historical events for Italy and for the whole world. In this years the role of saxophone in Italy developed and gained the trust of important composers such as Dallapiccola, Zandonai, Nono, Petrassi, Scelsi, Maderna, Donatoni and many others. Is interesting to notice how the repertory evolved in such a brief period, starting from simple forms and languages, and reaching, at the end, impressive technical levels, including also new techniques like the use of altissimo register or new interesting composition languages.

The saxophone started from a place of entertainment (except for few examples) in brief pieces, finishing to cover place as soloist in orchestra or part of the orchestra in big compositions such as Concerto per la notte di Natale by Dallapiccola, or Concerto for piano and orchestra by Maderna. The studies on this topic are few and of little importance, there is not literature and is easy to understand that the period is full of really important informations for the history of music and for the history of saxophone's repertory. As saxophonist and composer/analyst I think it is particularly important to study this subject in more depth to discover many lost musical pages through the deepening of information regarding authors, performers, musical instruments factories. As I explained in my research proposal, the action area is wide and involves academies, libraries, musical bands and private archives and it will be developed principally in Italy making the best with the network of professional contacts that I have built in recent years and investigating in an almost completely unexplored land of investigation.
